**A.) The following requirements apply to all Santa Ana Citizen Advisory Boards:**

- **Must be a registered voter \***
- **Must not serve as a treasurer of a political action committee**

In addition, the following requirements apply to the boards indicated:

Board of Recreation and Parks - Seven (7) council appointed positions plus one (1) member that represents the Santa Ana Unified School District, one (1) member that represents the Garden Grove Unified School District, and two (2) student representatives - Members prohibited from holding any paid office or employment in the city government.

Community Redevelopment and Housing Commission - Seven (7) council appointed positions, two (2) tenant representatives, and one (1) student representative - Members are prohibited from acquiring property within Redevelopment Project Areas and One of the two tenant representatives must be at least 62 years of age.

Environmental and Transportation Advisory Committee - Seven (7) council appointed positions, one (1) student representative, one (1) member must be nominated by the Greater Santa Ana Chamber of Commerce, and one (1) member nominated by the Hispanic Chamber of Commerce.

Historical Resources Commission - Seven (7) Council appointed positions plus one (1) member from the Planning Commission; and one (1) member from the Community Redevelopment Housing Commission - Members should possess an expertise and experience in the discipline of architecture, history, architectural history, planning or other historic preservation related discipline, such as urban planning, to the extent that such professionals are available in the community.

Personnel Board - Seven (7) council appointed positions - None of the members shall hold public office or employment in the city government or be a candidate for any other public office or position. None of the members shall be officers of any local, state, or national partisan political club or organization. Members are not eligible for appointment to any salaried office or employment in the service of the City of Santa Ana for a period of one (1) year after leaving the Board for any reason. Members of the Board may only be removed from office for cause.

Planning Commission - Seven (7) council appointed positions - Members prohibited from holding any paid office or employment in the city government.

Youth Commission\* - Twenty-one (21) members - (7) Regular and seven (7) Alternates, and seven (7) Associate members. Regular members must be 16-20 years of age (over 18 years of age must be registered voters), Alternate members must be d 14-18 years of age, and Associates must be 11-14 years of age.

Position on the following boards require appointment by the Santa Ana City Council and must be able to meet the additional criteria listed:

Civic Center Commission (2)

Orange County Water District Board (1)

- Must be at least 18 years old and a resident of Santa Ana
- Must be an owner of land in Division 8 of the District

Metropolitan Water District Board (1)

- Must be at least 18 years old and a resident of Santa Ana

Vector Control District Board (1)

- Must be at least 18 years old and a resident of Santa Ana
