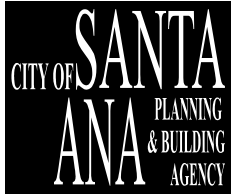

REQUEST FOR REMOVAL FROM THE SANTA ANA REGISTER OF HISTORICAL PROPERTIES SUBMITTAL CHECKLIST

Incomplete application submittals will not be accepted for consideration for removal from the Santa Ana Register of Historical Properties.

- Completed application.
- Property/Site photographs and photographic location map.
 - Include detailed photos showing areas where loss of architectural integrity occurs.
 - Map showing location/orientation of all site photos.
- Copy of Grant Deed or recent Title Report (no older than three months from application date) reflecting ownership of applicant.
- Fully dimensioned site plan which illustrates all structures on the site, distances to property lines, and parcel dimensions.
- Mailing labels for all property owners within 300-foot radius of subject property.
- Copy of permits, deed, historical documents, professional evaluations, or other such documents that verify the criteria for removal from the Santa Ana Register of Historical Properties, if applicable.

Note: Pursuant to the California Environmental Quality Act (CEQA), City staff will make a determination as to the environmental review requirements for this project.
