NOTICE IS HEREBY GIVEN that the City of Santa Ana will receive Bids on or before the hour of 2:00:59 pm, March 28, 2018 by the Public Works Agency Receptionist, Third Floor (see attached map), located at City Hall - Ross Annex, 20 Civic Center Plaza, M-22, Santa Ana, California 92701 for:

Bids Proposals shall be enclosed in a sealed envelope clearly marked on the outside with the above identified project number and name, and also marked "SEALED BID – DO NOT OPEN WITH REGULAR MAIL"

Scope of work includes removing existing asphalt pavement and replacing with new asphalt concrete pavement, replacement of damaged curb, sidewalk, and driveway approach. Related work includes mobilizing crews and equipment, implementing a construction safety plan, adjusting utility covers, traffic stripes and pavement markings, and, and all appurtenant work.

There is no scheduled Job Walk.

It is the BIDDER'S responsibility to ensure delivery of the Proposal prior to the bid opening hour. Contractors will be required to comply with the City's new security policy and sign-in with the receptionist on the first floor. Contractors will sign-in under Bid opening for Project 15-6825 & 18-6902 to receive elevator access to the 3rd floor lobby. Contractors should allow themselves additional time to register in order to avoid missing the time-stamp deadline.

Each bid shall be accompanied by a Bid Proposal Guaranty in the form of a cashier's or certified check payable to the City of Santa Ana, or Bid Bond issued by a corporate surety, in an amount not less than ten percent (10%) of the bid aggregate, as a guarantee that the Bidder will enter into the proposed contract if the same is awarded. The signature of the bidder on the bid bond must be notarized.

The City of Santa Ana reserves the right to reject any and all bids and to waive any minor or non-substantive irregularities in the bid documents.

Prior to bid opening, Bidders must possess or obtain a valid California Class "A" Contractor's license.

Addenda issued during the time the bid is advertised will be posted on the City of Santa Ana website. BIDDERS are responsible to become self-informed as to whether or not addenda have been issued.

#### COMMUNITY WORKFORCE AGREEMENT

For projects with bids greater than \$250,000 for prime multi-trade construction contracts (including all subcontractors) and over \$100,000 for specialty contracts (contracts either limited to a single trade or craft or limited to a singular scope of work), the CONTRACTOR shall adhere to the CITY'S Community Workforce Agreement (CWA). This project is considered a PRIME MULTI-TRADE CONSTRUCTION CONTRACT. The CWA is a pre-hire collective bargaining agreement, which establishes the labor relations policies and procedures for CONTRACTOR to follow in the crafts persons employed to complete the WORK OF IMPROVEMENT as more fully described in the CWA. #### CALIFORNIA LABOR CODE:

Any contract entered into pursuant to this notice will incorporate the provisions of the California State Labor Code.
