



City of Santa Ana CARES for Tenants Program Duplication of Benefits Analysis

A duplication of benefits occurs when a person or household receives financial assistance from multiple sources for the same purpose, and the total assistance received for that purpose is more than the total need for assistance. Grant funds from the **CARES for Tenants Program** may not be used to pay for a cost if another source of financial assistance is available to pay for the same cost.

I understand that the State of California Emergency Rental Assistance Program is the same source of funds as the City of Santa Ana CARES for Tenants Program. The State of California Emergency Rental Assistance Program offers to pay off 80% of the rent arrears owed by the Tenant in return for a landlord's forgiveness of the remaining 20% of the Tenant's rent arrears. If my landlord has already submitted an application for the State of California Emergency Rental Assistance Program, I shall not pursue receiving funds from this program and will immediately contact my case manager to stop this process.
